### 2. Review of activities

The following review of activities was also tabled and reported:

### 2020-22 Biennial Report

### 2022-23 Meetings programme

Over the past year the All-Party Group has hosted meetings at Westminster covering a wide range of issues, including UK innovation and scientific leadership in barley research, Net Zero innovations in the animal feed sector, Parliamentary launch of a new think-tank report on Precision Farming Technologies in the livestock sector, and a cross-industry examination of the policy landscape needed to deliver sustainable intensification in UK commodity crops.

# **Genetic Technology (Precision Breeding) Act**

Having first led calls for regulatory divergence from EU law on gene editing during the passage of the Agriculture Act in 2020, the All-Party Group actively supported the passage of the Genetic Technology (Precision Breeding) Act through both Houses of Parliament, regularly updating members and stakeholders and providing briefing papers, expert commentaries and a list of expert contacts for MPs, Peers and their researchers at each stage of the Bill's passage. The Group also co-ordinated a joint statement on gene editing and animal welfare signed by leading organisations and individuals across the scientific, breeding, farming, veterinary and input supply sectors.

# Report in preparation: Farming Innovations to Deliver Net Zero

In late 2022, the All-Party Parliamentary Group on Science & Technology in Agriculture launched a call for evidence into the farming technologies, innovations and practices which can help deliver on the UK's Net Zero commitments. Members notes that a brief report is in development, drawing on the written evidence submitted to the inquiry from a range of organisations and individuals, as well as presentations made to the All-Party Group by experts from different sectors.

## 3. Guest speakers

The AGM was also joined by two guest speakers from US gene editing firm Pairwise.

Haven Baker, Founder & Chief Business Officer, and Dan Jenkins, Head of Regulatory & Quality, described their company's focus on using gene editing technologies to promote healthier eating by improving the flavour and convenience of fresh vegetables and berry fruits. This included the recent approval and launch in the foodservice sector in Canada of mustard greens, gene editing for reduced bitterness and improved flavour. The presentation also included details of consumer research conducted in three US cities. The overwhelming response from consumers to the gene edited mustard green was positive.
